Indian Creek Nature Center founders BB Stamats and Jean O'Donnell understood this and in 1973 acted by creating Iowa's only private nonprofit nature center. Today woodlands, wetlands and prairies are home to many species of plants and wildlife that you, I, and our children can access seven days a week not far from home.

Four decades of community volunteers, Guild members, trust and board members; individual, family and business donors and a seriously dedicated and educated staff have understood and safeguarded a mutual belief that nothing can replace our interaction with nature.

Nature inspires most human invention, provides beauty and inspires art, and provides spiritual reprieve from everyday stress. Yet, for many of us, our immersion in nature has nearly been lost. When is the last time your child or grandchild watched a frog, tromped through a field while observing birds and butterflies, or helped turn maple sap into sweet, delicious syrup?

With exposure to nature one gains a better understanding of how it can give and also replenish itself when protected and respected. Time at the Nature Center can develop a respect for natural food sources; for instance, children can watch how bees toil long and hard to make honey.

When my presidential duties took me to the Center, its purpose and mission greeted my senses as I simply walked from my car to the 1932 barn which still houses Nature Center programs and

staff. I enjoyed the sound of laughing children with no media playing in the background. While taking in the smell of thawing ground I marveled at the amount of sap produced by each tree, often while listening to the beautiful sound of many birds. The mission is apparent as pride gleams from the Eagle Scouts and many Metro High School students who completed or worked on projects.

Accomplishments of the Nature Center in 2010 were:

1) Enhanced social media communications. 2) Transitioned ownership of a wonderful tract of land gifted by Carleen Grandon. The nearly 30 acres of ecologically significant land has been protected and will be prepared for public access. Some of the less ecologically healthy acres may be repurposed for commercial use, positioning the Nature Center for long-term success through endowment growth. 3) As we moved away from the immediacy of post-flood recovery we embarked on a planning and visioning process as staff and the board completed a consult through the Association of Nature Center Administrators (ANCA). The visioning process will continue through 2011 to address long-term needs: to move facilities to higher ground, expand programming, grow the endowment, and establish facility expansion goals. 4) Lastly, the Nature Center embarked on an initiative to educate and engage the public on controlling private land water runoff. This effort included installing permeable paving, selling rain barrels and hosting workshops.

The most lasting impact during my term as board president came from Rich Patterson and the Nature Center staff. I and many others—members and casual visitors alike—enjoy the fruits of their hard labor of love of nature. The dedication of these folks transcends the usual; the fiscal success of the Nature Center follows. Thank you to all who have made contributions to sustain this important corridor treasure, where nature immersion is just a few minutes away from our busy, technology-invaded lives.
